## Why Start a PAGE Affiliate?

Individuals, parents or teachers, often struggle to bring attention to the needs of gifted learners in their district and may be dismissed by those in positions of authority. Strength in numbers may be just what is needed to spur a more collaborative spirit with key personnel. PAGE Affiliate groups provide a place to meet, share and talk about best practices for gifted in the local area, as well as providing information, encouragement and support to everyone that works with gifted students.

Beginning an affiliate helps to align parents, teachers, administrators and other community members interested in advocating for students with gifted and talented learning needs.

- 1 person = A person concerned about gifted education
- 2 people = Two people who share common concerns about gifted education
- 3 people = A small group that seeking solutions for common concerns in gifted education
- 5 people = A reason to have regular meetings
- 10 people = The start of an organization with a mission, vision, and goals
- 25 people = An organization starting to see encouraging shifts in discussions about gifted education
- 50 people = A compelling organization helping gifted students, parents and educators thrive<sup>1</sup>

#### **Benefits of PAGE Affiliation**

Providing a Network for Parents, Educators, Administrators, and Students

- > PAGE advocates for gifted students and educators at the state and federal levels. PAGE affiliates provide grass-roots, local advocacy in their districts.

## Starting an Affiliate

Once your group has made the decision to work with others in your district, community, county, etc. to discuss how to best meet the needs of the gifted students in your area, you are ready to start an affiliate group of PAGE. Think of the PAGE affiliate group as a "PTA for gifted education". Remember, there is strength in numbers!

There is no magic set of rules or a formula to follow when starting a successful PAGE affiliate. However, PAGE requires the following three essentials, before your group will be considered an official PAGE affiliate.

- 1. **Eight or more people interested in joining PAGE or already current/paid members of PAGE.** Family memberships may count as two names for this purpose.
- 2. The group must **draft and agree upon Bylaws** to guide the work of the Affiliate group. See the sample on pages 11-13. The Affiliate bylaws will accompany the PAGE Affiliation application form.
- 3. The Affiliate must pay and stay current with annual PAGE Affiliate dues.
  - a. A notice of Affiliate due renewal is sent to the Affiliate President during August with a set due date of October 1<sup>st</sup> of each year in one lump sum payment. The amount for Affiliate due renewal is set during the January PAGE board meeting. The Affiliate dues for the 2017-2018 year is \$40.00 per Affiliate group.

## **Affiliate Organization**

The specific organization for each affiliate may be different to meet your specific needs. However, it is required to have the following four board positions within your affiliate group and should be on file with PAGE.

- 1. President
- 2. Vice-President
- 3. Treasurer
- 4. Secretary

Some affiliate groups have executive committees within those boards that have beyond the above four required positions, while others do not.

## **PAGE Expectations for All Affiliate Groups**

#### 1. Affiliate members are current paid members to PAGE

- a. Membership revenue helps PAGE to continue its advocacy efforts which are so essential to the success of the affiliates, PAGE, and advocacy efforts for the education of gifted students.
- b. General Membership and Affiliate Dues go towards supporting our Affiliates put on events, bring in speakers, support scholarship opportunities for students, etc.

#### 2. Complete all required paperwork as soon as possible and satisfy any outstanding payments

- a. Pay your dues on time
  - i. Initial Affiliate dues are required with the submission of the New Affiliate Application.
  - ii. Current Affiliates (created before 2017) All dues are required by October 1<sup>st</sup> of each year. Along with your submission of dues, email the Affiliate Director and Administrative Assistant a current list of those Affiliate Members that are also PAGE members (first/last name and email address). This allows a cross check that to ensure your Affiliate is receiving the appropriate level of benefits for the year.
- b. Submit the Speakers Bureau Reimbursement form promptly after a person from the Speakers Bureau has presented at your meeting.
- c. Submit forms and reserve rooms for Affiliate Weekend by the announced deadline. Any affiliate that is not current with its dues may not send delegates to Affiliate Weekend and will not be entitled to a free speaker from the Speakers Bureau.

#### 3. Create and Maintain an Affiliate Bank Account

- **a.** As an affiliate group, you will need your own bank account for deposit of any registration costs for events that you hold and to be able to pay for any speakers, venues, and other associated costs with hosting different events in your area.
- **b.** Apply for and set up a federal EIN (Employer Identification Number)
- **c.** Your Affiliate can also apply for non-profit/tax exempt [501(c)3] status. *This is not required but recommended.*
- **d.** File taxes in a timely fashion, if needed. It is highly recommended that your officers are aware of current IRS regulations for tax filing thresholds. Most Affiliates only raise small amounts of money and typically do not exceed the federal threshold, but is important for the officers to be aware of those regulations.

#### 4. General Liability Insurance for your Events, Meetings, etc.

- a. This is not required but recommended.
- b. PAGE has purchased a general liability policy which covers its members at PAGE sponsored events such as Affiliate Weekend and the State Conference. However, this coverage does not extend to the individual affiliates. Because the affiliates differ significantly in the number of people involved, the types of activities, and the frequency of activities, it is impossible to secure coverage for the Affiliates as a group. Please consult your local district policies regarding insurance and facilities use.

#### 5. Create an Affiliate Logo

- **a.** Each PAGE Affiliate should create their own logo to represent their group. This will be present on all of your printed materials, flyers, event posters, correspondence, etc.
- b. If an Affiliate would like to use the PAGE logo as their Affiliate Chapter's logo, the Affiliate is required to add PAGE as an additional insured group/organization under your General Liability Insurance Policy. Some policies may allow this for free and others may require a charge. Once you have secured this additional insurance, BEFORE use of the PAGE logo, the Affiliate must provide PAGE with a copy of the certificate of insurance as proof that you have secured this insurance and that PAGE is listed as the secondary not a primary on the policy.

#### 6. Communicate with PAGE

a. Keep PAGE aware of changes in leadership as they occur. Send all names and contact information to the

PAGE Administrative Assistant (<a href="mailto:kpowell@giftedpage.org">kpowell@giftedpage.org</a>) and Affiliate Director (<a href="mailto:Affiliatedirector@giftedpage.org">Affiliatedirector@giftedpage.org</a>)

- b. **Maintain an Affiliate Email Address,** which can be accessed by leaders and passed along when affiliate leadership changes occur. Free accounts are readily available through internet service providers such as Gmail. Yahoo. etc.
- c. Affiliate Leaders will be added to the PAGE Affiliate Leaders Facebook Page to share ideas, ask questions, and stay up-to-date with events from other state Affiliate Groups. When leadership changes, the new leadership will be added to the group and the outgoing leadership will stay part of the Affiliate Leaders Facebook page for up to 2 months to assist during the transition in your leadership. After that time, the previous Affiliate leadership will be removed from the Affiliate Leaders Facebook page.
- d. Participate in monthly online Affiliate Meetings with the PAGE Board.
  - i. This is not required, but recommended.
  - ii. The President and Vice-President will receive an email invitation from the Affiliate Director each month. These meetings will allow Affiliates to have recent information discussed at the PAGE Board meeting, convey any needs, and ask questions. If the President or Vice-President cannot attend, they may elect a designee from their Affiliate to join the meeting on their behalf. Make sure to RSVP with the Affiliate Director for who will be attending the meeting.
- e. **Check** the PAGE website and other social media to ensure they contain the most accurate information about your affiliate and leadership.
- f. **Let PAGE know** about any significant information, articles, or relevant events. Remember that the PAGE board is an organization of volunteers, so we may not be aware of all events at all times. Sharing is welcome. You can share this information with the PAGE Executive Secretary (<a href="kpowell@giftedpage.org">kpowell@giftedpage.org</a>) and Affiliate Director (Affliatedirector@giftedpage.org)

#### 7. Share PAGE communications with your affiliate members

- a. As the leader of an affiliate you may receive information from the PAGE Affiliate Director, PAGE President, other Board members, and PAGE Executive Secretary. Remember what is old news to you could be new and valuable to someone else. By sharing this information you help others see "the big picture" and why it is important to be a member of PAGE. It is imperative that everyone knows what is happening legislatively with education in general and gifted in particular.
- b. Share any appropriate information with your fellow officers and other members of your affiliate. Remember the affiliate may be well-established, but parents come and go.
- c. Share your Affiliate Website, Facebook, and/or other social media account links with PAGE. We will link this to our Affiliate page on the website, so others in your area can find and connect with you.
- d. Sign up for free PAGE electronic newsletters and connect to PAGE via other social media and remind local members to do so, too.
- e. Help publicize PAGE events, contests, and requests for "action" contacting elected officials about specific concerns. Often people do not know how state and federal issues impact their local districts and their own children.

## 8. Share your events with PAGE for publication on our website, Facebook, Twitter, and other social and print media materials.

a. Share details about upcoming meetings, activities and events in a timely fashion for posting to our social and print media outlets to assist in attendance for your Affiliate events.

#### 9. Support the Annual Conference

- a. Donate items or a complete basket for the conference raffle. (The proceeds go toward the student awards.) Each affiliate is asked to contribute to this event; details will be sent by the conference committee.
- b. Assist the conference planning committee. Help is needed before and during the conference. Some tasks must be done "on site" or with strict time limitations, but others can be done from your home and at your convenience
- c. Nominate educators, parents (including former affiliate leaders), or children for PAGE awards.
- d. Attend and urge other parents and school district staff to attend.

#### 10. Support the Affiliate Leadership Conference Weekend

a. This annual fall leadership training conference is a wonderful opportunity for current and future affiliate

leaders to learn more, network with other affiliates from across the state, hear what is happening at PDE, and interact with PAGE Board members. Affiliates may send two people at no cost for a shared room, food, and the conference. Additional people, including those working to start an affiliate, may attend for a nominal fee. The most up-to-date information about the Speakers Bureau and other forms are distributed at this event.

## 11. Help PAGE Grow

- a. Connect with neighboring affiliates. Help publicize their meetings and events. Work with them to create social and educational opportunities for gifted children, their parents, and their educators.
- b. Recruit speaker to join the Speakers Bureau do you have an outstanding Gifted Education teacher, School Psychologist, administrator, parent, etc. in your area that can share information with others, dedicated and knowledgeable parents, etc.? Then send them our way!
- c. Volunteer to participate on PAGE committees, board vacancies, submit articles for the website/Newsletter/Blog/etc.

## SAMPLE BYLAWS

## Article I Name and Purpose

Section 1: This organization shall be known as <u>Name</u>: an affiliate organization of the Pennsylvania Association for Gifted Education, Inc. (PAGE)

Section 2: The purpose of this organization shall be:

- A. To focus attention on mentally gifted children and their right to an appropriate education.
- B. To act as a resource for information and consultation in encouraging study and improvement of education of the mentally gifted.
- C. To educate the public about the needs of the gifted and the activities of the organization.
- D. To act as a support group for parents, children and all other persons interested in the growth and development of gifted children.
- E. To protect and improve existing legislation for the gifted.

## Article II Membership and Rules

Section 1: Membership shall be open to all persons interested in the purposes listed in Article I.

Although the organization is primarily interested in promoting its purpose in <u>school district/region of</u>
<u>Pennsylvania</u>, it is interested in gifted education throughout the state and the nation. It welcomes to its
membership persons who are not residents or do not currently have children enrolled in <u>school district/region of</u>
<u>Pennsylvania...</u>

Section 2: There shall be member dues, the amount of which shall be established by the Board annually.

## Article III Elected Officials

Section 1: The Board of the organization shall consist of the following elected officials: President, Vice-President, Secretary, Treasurer, Past President, and others as deemed necessary to pro-mote the goals of the organization.

- A. President: Presides over the organization, working closely with the Board to set goals and ensure that policies and directives are implemented; is the official representative of the affiliate; maintains contact with the state and regional officers of PAGE; and coordinates local meetings.
- B. Vice-President: Conducts organization business and presides over meetings in the absence of the President, as required by the President and/or board; and supports the goals of the organization as needed.
- C. Secretary: Keeps the meeting notes or minutes of all Board and organization meetings; maintains a contact list of all members; and disseminates meeting notes or minutes to all members.
- D. Treasurer: receives all income and pays all obligations of the affiliate; makes disbursements only as directed by the Board; prepares a financial report for all meetings; ensures all financial records and reports will be open to the general membership; and files taxes as required.
- E. Past President: Serves in an ex officio (non-voting) capacity. Offers advice, guidance and continuity to the Board.

Section 2: Each Board member shall serve a <u>#</u> year term of office, which begins after the <u>spring</u> meeting of the organization at which s/he was elected. In the event that any officer (except Past- President) is unable to complete his/her term, the Board shall fill the vacancy. Board members may <u>be re-elected/be re-elected for # terms/may not be re-elected</u>.

Section 3: All elected and appointed officers of the Board must be or become members of the Pennsylvania Association for Gifted Education. Go to <a href="https://www.giftedpage.org">www.giftedpage.org</a> to become a member and join PAGE.

Section 4: The Board shall act for the organization as necessary between organization meetings. A Board meeting can be called by the President, Vice-President and/or two other members of the Board. Such action shall be reported to the general membership at the next regularly scheduled meeting.

Section 5: A Board member may be removed from office when the following procedure has been observed:

- A. A written request from any two Board members, specifying the reasons for removal, will be given to the President or Vice-President. The Board will review the request within # business days.
- B. The general membership may petition the removal of a Board member by submitting a written request to any Board member. The request must be signed by <u>#</u> of general members in good standing and specify the reasons for the removal. The Board will re- view the request within <u>#</u> business days.
- C. Within <u>#</u> business days of receiving the complaint, the President (or Vice-President, should the complaint be registered against the President) will notify the Board member complained of in writing of the complaint.
- D. Within <u>#</u> business days of the Board's review of the complaint, the Board and the person in question will meet to discuss the complaint. The Board member who is the subject of the complaint shall be given adequate opportunity to respond to the complaint.
- E. Upon two thirds vote of approval from the members of the Board with voting rights, the Board member will be removed from his/her position. The Board shall name an interim person to function in that position until the next regularly scheduled election.
- F. The removal/change of PAGE Board member shall be announced at the organization's next general membership meeting.

## Article IV Meetings

- Section 1: The Board shall meet not less than <u># times per year</u>.
- Section 2: General membership meetings shall be held #times per year, with an annual business meeting held in month.
- Section 3: Meetings shall be conducted using a method of parliamentary procedure, such as Robert's Rules of Order.

### Article V Amendments

Section 1: Amendments to these bylaws may be proposed by any member in good standing.

Section 2: Such proposed amendments shall be presented in writing to any member of the Board, at least <u>#</u> days prior to the annual business meeting. The Board shall study the proposed amendment(s) and present them, along with a recommendation to accept or reject, at the annual business meeting.

SAMPLE BYLAWS

Article VI Adoption of the Bylaws These bylaws and all amendments shall be adopted by a majority vote of the members present at a business meeting of the affiliate.

## Article VII Nomination and Election of Board Members

- Section 1: The election of Board members shall occur at an annual business meeting every #\_year(s).
- Section 2: At the <u>month Board meeting every # year(s)</u>, the President shall appoint a nominating committee consisting of at least <u># Board members</u>.
- Section 3: The nominating committee shall inform the membership that nominations are open for # week(s).
- Section 3: The nominating committee will then present the list of candidates to the Board at the <u>month Board meeting</u> and present the list to the general membership at the annual business meeting.
- Section 4: A current member may nominate another current member from the floor, provided the nominee has approved the presentation of his/her name.
- Section 5: Only those in attendance whose membership was paid prior to the start of the meeting may vote.
- Section 6: A majority of the members present at this meeting will elect the Board.

## Article VIII Quorum

- Section 1: A quorum shall consist of the members in attendance at any general membership or business meeting of the organization.
- Section 2: A majority of Board members constitutes a quorum to the conduct business of the organization.
- Section 3: Board members may participate in a meeting of the Board or of a committee of the Board by means of conference telephone or similar electronic equipment as long as all persons participating in the meeting can hear each other.
